On the death of the last surviving party, ownership of the account passes as a part of the last surviving party's estate under the last surviving party's estate under the last surviving party's will or by intestacy. The financial institution may pay funds in the account to a convenience signer before the financial institution may pay funds in the account to a convenience signer before the financial institution receives notice of the death of the last surviving party.
